My dear Dr. Williams;

About two weeks ago I wrote to you relative to the time when I might expect to sail for China, but to date I have not been favored with a reply. I know that you are a very busy person, hence I have very reluctantly decided to write again, but it is imperative that I have some definite information in order that I may make the necessary arrangements at the Hospital and that they may be prepared to have some one ready to fill my place, has left me no alternative other than to again request the information which I desire. If I am to go there is yet a great deal to do and many adjustments to be made, so that I feel that I must know definitely and decidedly just where we stand in the matter.

I would greatly appreciate the courtesy if you would let me know when I may expect the outfit money and also the extra allowance of two hundred dollars.

I am sure that you will appreciate the position in which I find myself - I do not know anything definite and cannot afford to give up my position until I am sure that I am going; on the other hand, I must know in time to allow the officials at the Hospital to make the necessary arrangements toward filling my place.

I trust that I shall receive a reply at once and take the liberty of thanking you in advance for the two items of information which I feel that I must have at once, namely: Exactly when I am to sail and when I may expect the outfit money and the additional allowance. The extra allowance could be sent later, but the outfit money, I feel, should be sent at once in order that I may do some of the many things which must be done with same.

My dear Dr. Williams,

Mr. Anslie has just gotten back. I had a talk with him tonight, and ^{it is} because of the results of that talk that I am following up so closely my letter of yesterday. Mr. Anslie wants to know whether you would be willing to have the Temple furnish the \$200. for my outfit and the Y. W. of Nanjing furnish the \$400. on my home. It of course amounts to the same thing, but he seems to think that in as much as I am the first girl going from the Temple, the church would take a great interest in the outfit. He has promised to write you in the morning, but he is such a busy person, and I am so eager to have everything settled, that I took the liberty of also writing.

When I got to the hospital this morning I found that Dr. Brennan was saying that I

was not going to China. I decided to have nothing to say at present, just to wait a few days, hoping in that time to hear from you the definite time of my sailing. Then I shall disillusion him.

Do you still want me to attend the conference of Outgoing Missionaries? I feel may I ask you what your plans are for me. It is all very new and strange to me. Beside that, being a Presbyterian conference, I feel very much of an outsider. I should like very much to attend, if a "mere Christian" should be wanted.

My dear Dr. Williams:-

I have been out of the city so constantly this spring and am only back for a day or two, when I leave for another trip that will take me as far west as Kansas City, that I have been unable to take up the matter of Miss Grace Bauer until to-day. Miss Bauer is an unusual young woman and it is with great satisfaction that I enter into her plans.

I have just had a talk with her and the matter that concerns her most is about leaving her parents with a house in the present condition regarding the mortgage. She has been very dutiful to her parents and it is altogether praiseworthy that she wants this adjusted so that she will be free to give her best to her work in China.

As I understand it she wants to get a mortgage on the property for \$1600 and in order to do this she will have to secure \$400; also she will require \$200 for her outfit. I think in your former letter you suggested that the Christian Temple assume half of the \$400 and the University would look out for the other half and her outfit, all of which was quite satisfactory to me, only I would like to make a little change in the arrangement. Suppose you let the Christian Temple provide for her outfit? She has lots of friends here who I suppose would be especially moved to render assistance in this and who would do it with joy. In that event the University could assume the \$400. As you see the amount of money is the same only the arrangement of it is a trifle different.

I hope this plan will meet with your approval and that you will advise me regarding it. Everything will be all ready with this understanding. It will not be necessary to send the \$400 now, some time in June would be quite satisfactory, only to have it permanently settled now. The Christian Temple will furnish her, however, with \$200 now as she wants to take some little time in getting the outfit.

Your special delivery letter of May 25th just received this morning. I had dictated the above letter on Saturday which would have replied to the things you wanted to know. I shall enclose with this letter check for two hundred dollars on outfit and another check for two hundred dollars for relief on your personal problem on the understanding that Dr. Ainslie is going to arrange

Dear Dr. Ainslie:

Your letter of May 27th received.

I am delighted to know of the deep interest of the Church in Miss Bauer's plans and their readiness to co-operate in the matter of her outfit.

I think we might adjust the matter of \$200 and outfit as against \$200 as the assistance in the matter of the mortgage. As an item of bookkeeping it will not be so easy for us here however. I shall be under the necessity of reporting to the Trustees \$200 for outfit and \$200 for the mortgage. If your church provides an amount not less than \$200 toward Miss Bauer's outfit and she is enabled in that way to provide all the outfit needed, there will be no objection for using the \$200 nominally for outfit, in clearing off that much toward the mortgage. I am under difficulty of taking even \$200 from University funds to settle an obligation for one before going to the field. There are so many things in this line on the part of almost all applicants for Mission work that the Mission Boards have to make an unvarying rule that they cannot undertake any debts or obligations before a candidate is appointed to the field.

In the case of Miss Bauer however, I felt it was absolutely necessary that we have her services at the earliest date and that we must effect a special arrangement to meet her case. If it does not trouble your conscience to understand that upon our books we will grant \$200 toward Miss Bauer's outfit and we will specially provide another \$200 toward the mortgage obligation. Miss Bauer will require all of the \$200 for outfit and no less amount should be undertaken by the church.

We are so happy to know that Miss Bauer is going to Hanking. We are so happy to have this relationship with your church and yourself. She will be a strong force on our staff.

Dear Miss Bauer:

It is a matter of great regret to me that I was not here at the time you arrived for the Conference, for I am sure I might have made it much pleasanter for you. I hope, however, you felt that it was a real advantage to meet somebody of the same purpose, in looking forward to the same kind of work. It had not occurred to me that you might be taking further physical examination, since we had received your medical blank. It was a disadvantage, too, that Dr. Newton did not have your medical blank, which was in the files in my office, before taking up the examination. She has expressed the desire of having microscopic analyses made by someone other than yourself, so I ventured to write, asking Dr. Ward if she could arrange to have this done.

If you very much desire, we may be able to secure a sailing a little later than the 26th of July, although the bookings are very well filled in and the "Venezuela" is a good boat. I think it would be safest to make all your plans to go on the "Venezuela", and if you need to make a change, we will make shift on other sailings.

I am glad you were at the dinner on Monday night and could hear Mr. Speer at that time and also Dr. Fosdick. I regard them as two of the greatest preachers to the young people of America. Mrs. Williams regretted very much that her dental work prevented her from being present at the Conference.

Dear Miss Bauer:

Your reservations are made on the "Venezuela", sailing the 25th of July. You should allow yourself a day or two margin between the arrival of your train at San Francisco and the departure of the "Venezuela", as a precaution against accident or delay en route.

I hope all your plans are developing in a satisfactory way, particularly, that Dr. Ainslie has been accomplished in a way to relieve your mind entirely.

I still regret very much that I could not be here when you arrived at the Conference. I find that the letter which I had written to Mr. Carter, outlining all arrangements made for your comfort and convenience, on the 3rd of June, did not get into his hands until the 10th, several days after you were at the Conference. Why this delay, I have been unable to discover, and it may account in part for any lack of arrangements completed in your behalf upon your arrival. It was also a matter of great regret that Mrs. Williams was absolutely unable to come in to any of the Sessions of the Conference, for she would so much liked to have been with you to talk over matters.

I find that if you desire, I can secure reservations on the "Empress of Asia", sailing from Vancouver on the 4th of September, which would get you to Hanking just in time for the opening of the Language School. Dr. and Mrs. Daniels are sailing on that boat. Mr. and Mrs. Speers will probably be sailing on that boat, too, together with other friends. If you sail on the "Venezuela", which is a fine boat, it will get you to Hanking about the end of August and allow you three or four weeks to get settled in the knowledge of the Hospital situation and time for your own private arrangements before entering the Language School course. The "Venezuela" would offer real advantages over the "Empress" in that respect, while on the "Empress" you would be sure of the company of the Daniels.

Dear Mr. Williams,

I went to Baltimore Tuesday after-
noon and spent Wednesday morning with
Miss Bauer. She will I am sure be a help
to us though perhaps not to the extent
that we had been led to hope. The
facts about her are that she is neither
a nurse nor a pathologist. She is
a laboratory technician with previous high
school and business course. She has
been in the laboratory for three years
and can do technician's work but not
pathologic diagnosis. She can do
Wasserman reactions which will be a big
help.

I really think that eventually she will be
doing office as well as laboratory work.

Miss Walker has never been well and never very happy in China, and she has told me in confidence that she will be leaving next year. She asked me not to say anything about it yet, but told me to look for some one. I think Miss Bauer may be able to do our tests and Miss Walker's work too.

Another thing that worries me somewhat is that you have evidently talked to Miss Bauer of a three year arrangement. If she only goes for three years she ought to go at once to work and maybe get all she can of Chinese with a private teacher. If she goes into it as a life work of course she should go into language school. I think we can not afford to let her go to

Language School on any three year
Contract. We ought to have a clear under-
standing before she sails.

I do not see how her salary is to be
paid except as Mrs Walker's is, from current
receipts. The China Medical Board money
covers only nurses and a doctor. She
will need to take a Microtome and complete
outfit for Wassermann tests as well as some
special Haemocytometers. They will all cost
perhaps ^{US} 350.00. I have asked her to
prepare and forward to me a complete
list with prices.

Yesterday I spent in Washington, working on
an X-ray outfit which the War Dept promise
to sell us. They agreed to send me an
estimate on the outfit and accessory supplies
ordered tomorrow. I shall send it on to Mr Carter later
as ever yours Dwight.

My dear Miss Bauer:

I just received, this morning, a letter from Dr. Sloan, after his pleasant visit with you in Baltimore.

He suggests that you will require a Microtome and complete outfit for Wasserman tests, etc., and that the cost would be about \$350. We will arrange at the office for those matters as soon as you send the bill to us through Dr. Sloan.

Dr. Sloan, after his conversation, suggests that there might be a difference of understanding between us in regard to the term of service, and I would like to have that matter entirely cleared up.

My recollection and impression was that we considered the three-year term, but a very important matter was still under consideration by you. Later, you reported that that matter was entirely settled. Then, we proceeded upon the definite assumption that you were going for a life-term, under the regular conditions of furlough, etc., as obtained with other missionaries. Upon that assumption, we would plan that you would enter the Language School and acquire the language, and would also help, as far as possible, toward your former obligations.

The usual arrangements for short-term work for three years are that we do not provide an outfit; we provide for travel both ways, but we do not provide for language study. Too much time would be occupied in language study out of the relatively short period to make it worth while.

Have there been other developments since our former understanding? Do you desire now to go only on the three-year term? It will not be impossible to do that, but it would be wise for us to understand, as soon as possible, the terms that apply on the two different bases of appointment, so that there will be no misunderstandings later. Will you write me at your earliest convenience what your decision is?

I hope that there is no question about your going as a regular missionary, or a long-term, with the idea of learning



In conversation I will make enough clear with Dr Sloan - I believe it will be better for you to enter the language school and Dr Sloan nor I nor you need say much about a three year term - If it develops that you should not go on longer we can face that decision with the facts
The convictions that Mrs Williams and I

You are most fortunate in going to the home of Dr & Mrs Hutchison they are charming people socially and missionaries of the finest ideals and spirit - You will find Mrs Hutchison like a mother and they have dear children who will add their charm to the home. - Your mother should be comforted - Dr Sloan is very outspoken on any arrangement but very true to his colleagues. -

We understand that you are going definitely for three years and possibly for life - You will enter the Sanguys School as if for life work. - If you should need to leave the work at the end of three years you will return half the outfit allowance \$100.00 and ~~return one half of your return fund~~ - if you will ~~ask~~ will ask nothing further.



Dear Dr. North:

I am just about to arrive in Seattle. I went from Shanghai to Japan the first part of April. Stayed in Japan awhile hoping to find some work there that would tide me over until the Nanking situation settled a little. I thought being near it would be easier to return should I be needed. I was unable to find work. This being the case it seemed wisest to follow the advise of Dr. Bowen and the other University folks and come home.

I fear my finances are in rather a mix up. Before leaving Shanghai I drew my April and May salary. This was the field salary without the ten dollar deduction that you have been paying for me at home. In addition to this I was given 200.00 Mex., refugee fund and \$450.00 gold for travel.

Just before leaving Japan I wrote Miss Russell in Shanghai asking her to send me about fifty dollars more for travel just in case I should not have sufficient. She send me a draft for \$130.00 gold which she said was to cover my May and June salary, on home salary basis, less the ten dollars per month which was being paid at home. In the first place I had already received May salary and in the second place while I am receiving a home salary there is no reason to make the ten dollars a separate payment.

I have not yet cashed the draft sent by Miss Russell and am rather hoping not to need it ~~until~~ for travel home. When I reach home I shall send my expense account and I hope you will not find this mix up difficult to straighten out.

I am stopping for a few days on the West Coast to see Miss Wright and Miss Chace, who were formally nurses in Nanking.

I shall appreciate your sending me any information from time to time which you have in regard to Nanking. I greatly appreciate the kindness of the Board for sending information to my family ~~from time to time~~ during the difficulties in Nanking.

My dear Miss Bauer:

We are glad to have word that you are so near home. Every bit of information about your experiences and plans has been eagerly seized and shared. Anxiety, inquiry, relief and concern have been our recurring emotions. We have endeavored to inform your relatives as promptly as possible of news about you.

Plans must now be made for adjusting ourselves and the University to the new conditions. Some of these we hope to announce shortly. It is clear that some form of emergency campaign will be necessary to secure funds to carry us along. President Bowen has approved. Some members of the staff will be called on for active help. All will be rendering assistance by the spirit in which the past experiences and present policies are interpreted in such contacts as you may have with the press and public. The situation changes rapidly and the tendency of the press to seize the sensational or controversial or to represent (accurately or inadequately) the opinions of the one as typical of the many makes difficult keeping a fair and well-balanced view before the public. The public especially needs to understand the good-will and self-sacrificing spirit displayed by so many of the Chinese students and staff and others.

In another way you can render valuable assistance. The University list of donors or prospects for this emergency appeal is extremely meagre - scarcely a handful of names. If you would find it possible to send us lists of persons in the communities you know to whom it might be worth while for the University to appeal by letter or otherwise, it would be very helpful. Such lists should give names, initials, addresses, etc., very accurately.

Because of the probable shortage in personal funds, we are enclosing a check for \$250.00 covering an emergency re-outfit allowance granted by the trustees as a purely provisional measure to give you immediate assistance in re-outfitting, pending the determination of a more comprehensive arrangement. This amount will be subject to later adjustment under whatever policy is definitely determined upon

In response to your statement of your confused finances given in your letter of May 23, we have this suggestion to make. First, that you endorse to the University of Nanking and send to us the \$130. gold which







We have your letters of June 19th and June 21st, together with your check for \$130. I note in your letter of June 21st that you state you will shortly be sending your travel account. Thus far, I believe, we have not received it.

As instructed in your letter of June 21 to the Loan Association, our Treasurer is discontinuing forwarding the \$10. a month to your father, Mr. Conrad Bauer. Please note that the last deduction was for the month of May and that no deduction was made from your June salary as was implied in an earlier letter from this office.

At a meeting of the Executive Committee of the University of Nanking on June 29th, it was voted that your furlough salary should be continued until October 31, 1927 and that your emergency outfit allowance should be fixed at US \$250.00. We trust that this financial arrangement will be satisfactory to you and will give you time to adjust your personal plans and secure other employment pending the reopening of a way for a return to China. I believe that on your outfit allowance you have received both US \$250. from our New York office and Mex.\$200. from the Shanghai office of the University. In this case there should be a refund to this office of Mex.\$200. which we have computed to amount to US \$90.90.

We wish to assure you of the sincere interest of our New York office and our desire to render whatever assistance is possible. The Board of Trustees is anxious to provide as liberally as they can for the needs of the University of Nanking staff even though they are still facing a very serious deficit in the emergency fund.

Our letters from the Shanghai office of the University indicate a slow but encouraging progress and we most sincerely hope that within a few months the situation at Nanking will have returned to more normal conditions.



My dear Miss Bauer,

We have your letter of July 31, stating that you have accepted a position as laboratory technician, and that you probably will not need to have your furlough salary continued. It is good to know that you have thus found satisfactory employment, and I trust that your position has proven a suitable and pleasant one.

I am enclosing a statement of your account from the time of your departure for America to the first of August. If our records are correct, on August 1st you owed the refund of \$90.90 and the University had agreed to continue your salary for four months more if needed, a total of \$300.00. If you still find that you do not need further financial assistance from the University, it might be a satisfactory adjustment if we charged the refund of \$90.90 against your salary for August and a part of September, and recorded the remainder of the salary as waived at your request. This has been the settlement made by two or three other members of the staff under similar circumstances.

The Board of Trustees deeply appreciate the unselfish spirit shown by such members of the Nanking staff as yourself. All of you have this year made many heavy sacrifices for the cause of Christ in China. I am glad to know that your interest still locks toward Nanking. My own feeling is that there is still lots of work for all of us to do in China, and that sooner or later the way will reopen for us to go ahead with it. We are anxious to keep in touch with all the Nanking staff, and to know your address and your plans.
