My dear Miss Bauers:

It occurred to me sometime ago that I was remiss in not discussing a little more in detail with you when you were here in the office the usual routine matter of health examinations. Most of our Mission Boards and College Boards try to adhere pretty closely to the wise procedure of having missionaries arriving on furlough undergo a health examination at the earliest convenient date. This is of great value in indicating whether the missionary should have any special medical attention during furlough, and is <sup>particularly</sup> ~~pretty~~ valuable wherever it is found that some fairly prolonged treatment is desirable in order to put an individual in the best physical condition for returning to the field at the end of furlough.

I believe it would be wise for you to follow this usual custom of having a thorough health examination in the fairly near future. If you are planning to be in New York at any time soon, this could be handled for you by Dr. J. G. Vaughan the medical secretary of the Methodist Board. If you are not planning to leave Baltimore very soon you could undoubtedly arrange for an examination there. Our Hanking regulations authorize us to pay up to \$5.00 to cover the cost of such an examination, although we are always grateful when doctors are willing to make such an examination without charge as a contribution to the missionary enterprise.

I remember that two or three years ago we received word that you had been having rather serious trouble of some kind. I hope that the difficulties have cleared up in a satisfactory way though possibly some further preventive or remedial treatment might be of value, this year. There is also the question of how far you should allow yourself to engage in full time study, <sup>when</sup> ~~some~~ <sup>some</sup> measure of rest and relaxation would be very beneficial.

These are all random comments and suggestions and some of them may not be at all applicable to your particular case. We would, however, be grateful if you would let us know just how these health matters stand.

My dear Miss Bauers

I have just received both from Miss Priest and Dr. Daniels the suggestion that we should raise with you the question of whether we should not ask our Nanking Board of Founders to make at least a modest study allowance to assist with the expense of your study here in America during the coming year. Neither Miss Priest nor Dr. Daniels felt themselves in a position to make any definite recommendations as to the amount of such a grant, but asked that we consult frankly with you concerning the matter.

When you were in the office, we discussed in a general way your plans for this year, but I do not have them in mind clearly enough to be in a position to make any very definite recommendations to our Nanking Founders. I would be grateful therefore if you would write me quite frankly on the subject, telling us about your plans for the year and indicating the special costs which your study will involve. Our Board of Founders will probably not be able to go beyond the very modest study allowances provided by the cooperating Mission Boards to their missionaries on furlough, but we hope that they will at least be willing to go that far if your actual study expenses require it.

Dear Mr. Garside:

It has been a long time since your letters of the 14th were received. Hope my delay in answering has not caused you any inconvenience. Shall try to do better in the future.

After receiving your letter I went to the Howard A Kelly Hospital, where I trained, to see about the physical examination. They said that they would do it, but advised that I wait until hayfever has fully passed. My hayfever enemies still seem to live in America. Am practically free of it all the time ~~of~~ in China. I am practically over it now and shall be going to Kelly's in the next couple weeks for the examination.

I still have some sciatic trouble, but am certainly better than three years ago.

Tomorrow I am starting work at Hopkins. For the next two months am taking a bacteriology course with the medical students. From correspondence while I was still in China, I understand there is to be no tuition. They requested that ~~Arthur~~ I furnish my own microscope, which Arthur Thomas Company has very kindly loan me. When the bacteriology is finished I hope to get more work in the hospital laboratories.

If there is free tuition at Hopkins, which I have every reason to expect, I need no help for my work there. The thing that Miss Priest and Dr. Daniels were thinking of was work in Porto Rica. I could get valuable work there, at least I think I could. However I can't go to Porto Rica unless I could have sufficient study allowance to cover travel and extra living expenses there.

In answer to a request from Dr. Hume the School of Tropical Medicine in San Juan, Puerto Rico have offered me the use of the laboratories for any line of work, in fact they suggested that I spend my whole furlough there. It is a marvelous opportunity. Dr. Hume advises it. Dr. Daniels and Dr. Trimmer would like me to do it. There are two hinderances. One is the need for study allowance. The other is the necessity of leaving my mother. You solve the former and I shall have to solve the latter.

The matter stands that for work in Baltimore, I donot need a study allowance. In order to take advantage of the opportunity in Puerto Rico I need help. I hope I have made myself clear.

I was in Philadelphia last week. Went up especially to take to Arthur Thomas Company the parts of two Dare Hemoglobinometers which they had repaired, but they still were not right. These should be mailed back to Nanking without further charge. I also turned over to them two oil of emersion objectives and the plungers from the colorimeter to be repaired if possible. There is no hurry about the last two items. If they can be re-

paired, shall have to find out from you how the charge will go through here. I can take the objectives and plungers back to China with me when I go.

On my way to Philadelphia I met Dr. Shields on the ~~the~~ train. We had a nice vist from Baltimore to Philadelphia.

If when the Ginling motion picture reaches you, <sup>and</sup> I can be of any assistance in spreading it in Baltimore, I shall be glad to do my part. When I first wrote you I had in mind that reel on Nanking that was made about three years ago. Having such intimate knowledge of what was in the reel I believe I could make good use of it in small groups. However if Mr. Sherwood and Mrs. Macmillian donot think it is good publicity material I abide by their opinion.

People are interested in China. There is no difficulty in gathering audiences. The difficulty with me is to find the prop~~er~~ing to say.

I forgot to mention that while I was in Philadelphia ~~Arthur~~ Arthur Thomas Company arranged for me to visit several interesting laboratories. I especially liked Post-graduate. Should like to go back and spend about a week there.

My dear Miss Bauers:

Thank you for your letter of September 30th. It should have been acknowledged before this, but suffered the misfortune of being near the bottom of a formidable pile of unanswered correspondence.

We note that you were planning to have a physical examination about the middle of October, so no doubt we will be having some report of the results within a short time. We hope that the examination will show you are in good condition physically - but it is quite a common occurrence to find that our staff members coming on furlough are in need of some special attention as a result of their strenuous years on the field. So if your doctors advise any special health measures while you are in America this year, we must guard against your becoming so busy that you will not find time to follow their advice.

Within the next two or three weeks we probably will be having a meeting of our Nanking Executive Committee. At that time I would like to present any requests we should make for study allowances. Am I correct in assuming that you are planning to spend October and November at Johns Hopkins and that you might thereafter like to spend some time in Porto Rico if necessary arrangements can be made? Can you give me fairly definite estimates as to exactly what expenses would be involved in your going to Porto Rico? How much would you need for travel? What extra living expenses would be necessary (estimated either on a weekly or a monthly basis)? How many months would you plan to spend there? We cannot expect our Executive Committee to take any definite action unless we can present a clear-cut estimate of expenses upon which they can plan.

I believe that the proper procedure with regard to the expenses for the repairs Arthur Thomas Company is making on the instruments you describe will be for them to send us their bill in the usual way. We can then make payments in due course and will report the matter to Miss Priest in Nanking. I assume that she knows these repairs are being made and plans to have the cost charged against the Hospital account.

At the present time we have two sets of motion pictures from Nankings-- first the release prepared by Mr. Wheeler two years ago

showing the city of Nanking in general and the University of Nanking and Ginling College in particular. Second, the new motion picture story "It Happened at Ginling" which is in three reels and lasts about forty-five minutes. We will be glad to let you have either or both these subjects as you may find it possible to use them to the best advantage. We are having a great many calls for the Ginling film (of which we have had two copies made) so we might have to do a little investigating to discover the most satisfactory date when the film would be available for your use.

If you are able to discover either in Baltimore or elsewhere present or potential friends of Nanking or Ginling whom you would like to have some help in cultivating, it might be possible for Mr. Sherwood or Mrs. Macmillan or some of our other representatives of the China Colleges to visit Baltimore and help you with this work.

Dear Mr. Garside:

Your letter of Oct. 30th should have been answered before this, but the days are so full.

I am enclosing the report of the physical examination, which I am sure you will consider useless. I was disgusted with the way the examination was done. This was only increased when the report came. He did not laboratory work. Went over my heart and lungs carefully, looked down my throat and punched around my forehead a little. He then called the examination finished. Oh yes, he did take my blood pressure. When he started to leave I called him back regarding a hernia and the sciatic trouble.

Since having the above examination the Metropolitan Life Insurance, in which I hold a small policy, has offered me a Life Extension Institute examination free. I now have all the papers, and hope to have the examination soon.

I am now studying at Hopkins. Rather expect to continue here until the end of January. Then I thought I might go to Puerto Rico for about three months, if a way can be found to finance it.

I went to Cooke's for information regarding transportation to San Juan. There is a freight line out of Baltimore, round trip rate \$81.00 There is an additional Government tax of \$5.00 on the ticket. This is the Baltimore-Insular Line, Inc., A. H. Bull & Co., Inc., General Agents, 115 Broad Street, New York. Maybe you could get a better rate through your office than I can get through Cooke.

There is another Line "The New York and Porto Rico Steamship Company" out of New York. Cooke quoted tickets as low as \$70.00, but I have to get up to New York, so I don't know that there would be much saved. It is more convenient to go from Baltimore, if it can be arranged.

I have written to Puerto Rico to try to get information on cost of living there. As soon as I get an answer will send it on to you. If it does not come before the Board meeting maybe you could venture a guess on that.

I have had a letter from Arthur Thomas quoting \$12.50 for the repair of the ~~two oil of~~ Bausch & Lomb Objective. will \$4.50 for the repair of the plungers. Their letter is waiting an answer, to which I can now attend in that I have the information from you regarding the way by which the charge can be put through.

May I put in a request for the Motion Picture Story, "It Happened in Ginling" for the first part of January? There is a group of Young women who want to put on a missionary program or rather a China program

Dear Mr. Garside:

Your letters of the 15th and 21st received.

Mrs. Macmillan wrote me regarding the Ginling ~~and~~ motion picture film. I have just answered her letter. She didnt mention ~~the~~ Nanking film and seemed a little uncertain about letting us have the one of Ginling. I am hoping she will think us worthy of it. There are a few of us in the church who are very eager to educate the people to missions. I believe the pictures will help.

I thank you for arranging for the study allowance. I have just had an answer to my inquiry to Puerto Rico for living expenses. They quote ~~sixty~~ dollars a month and up. They sounds pretty steep, but with ~~the~~ the allowance you have granted I think I can manage.

I am just finishing my first term of work at Hopkins. The second term starts the first of December and ends the end of January. I think now that I shall stay through the second term and then start to Puerto Rica the first of February. ~~I think now~~ I should like to put in about three months there.

In a recent letter from Dr. Brady he complained that the centrifuge in Nanking was not running well. I knew that before I left and had talked with Arthur Thomas regarding the matter when I was in Philadelphia. They suggested that the difficulty might be the field coils and said that they could have new ones furnished from the factory. I have written Arthur Thomas, giving them the number of the centrifuge and told them that they complained from Nanking that the centrifuge ran slowly and heated quickly. If they thought this was due to the field coils I asked them to send new ones to the University of Nanking, Nanking and send the bill to you. Hope this meets with your approval. I read with interest the factory's suggestion regarding the centrifuge. They are probably right. The worn armature is probably the reason for heating. However I know that the University tried to replace some coils for us. I am not enough of an electrician to know whether that is a field coil or not, but I am suspicious that it is.

I feel rather sure with the proper parts for the centrifuge the repairs could be done in Nanking. Many times in the last few years we had the thing to pieces. So many times have I worked over it, that I pretty well know how things stand. I feel that it would only be wasting time to delay longer by writing to Nanking.

I am sending your letter and a copy of this letter to Mr. B. A. Garside in the New York office asking him that he confirm the order of Armature, set of field coils, upper and lower bearings and carbon brushes as suggested by the factory.

As soon as you receive his confirmation of the order kindly ship said parts at once to the University of Nanking. I think there is decided advantage in sending the parts by parcel post instead of freight, therefore suggest that you follow the factory's suggestion of splitting the parts up into smaller packages. 

Dear Horton:

Strange as it may seem I have finally arrived in Puerto Rico. Have been here about a week and a half. Am delighted with the School of Tropical Medicine. Expect to have a very profitable three months. I wonder why more folks from China have not come here. Everyone is gracious. The whole institution is at my service. There are many mutual friends. If you see Dr. Hume tell him I am enjoying it here and certainly appreciate his assistance in getting me here.

When I came through New York I saw Mr. Garside. I asked him if he thought it would be possible for me to delay my return to Nanking by a month or so. He said the matter laid with the field. If you were willing he was and that I should write you. He also said, in that I had stayed more than an year over my required term the extended furlough might be arranged on that basis.

My reason for making this request is health. As you know I have been having my pet leg treated. The doctors say that absolutely it can be cured. Even though my faith is sometimes weak I should like to give them the chance. I shall return for treatment as soon as I get back to Baltimore, which I expect to be about the first of July. In the meantime I am following their instructions for certain exercises while here.

When I left the doctor was rather reluctant to make any definite statement. He questioned whether it would be wise for me to make definite plan to leave Baltimore the end of July, which is about the time I should have to leave were I to be back in Nanking the first of September. He preferred that I plan to be at home about a month longer. I told him I would take it up with the Board.

Therefore I should like to request that we let things ride until I get back home, tentatively planning to get back to Nanking about the first of October. Mr. Garside said as soon as we knew how things stood he could cable when you could expect me.

I wish I knew your fall plans, then I would be in a better position to judge as to whether or not it is all right for me to delay a little. Yeh Ku wrote me that you had some plans for the laboratory which you had gone over with him and of which you would write me, but I know how much chance you get to write letters. In the meantime when you have to make some decisions about the work, do whatever seems best and I will fit in with whatever you do.

I saw Florence and Van when I came through New York. Florence says she is going to visit us for a few months. Van says someday she was coming to spend a year or two. I assured her there would be plenty of repairing to be done when she got there and the sooner she came the better. Incidentally I hope you are not saving any repairing for me. Well and if you are, for one year I have gotten absolutely joy out of seeing a sterilizer, pipe, etc. leaking, and knowing that it was not on my body to see that it was fixed.



Dear Mr. Garside,

Your letter of July 30th, enclosing check for \$13.50 for medical bills, received. I havenot answered sooner because I was waiting until I could see Dr. Ward and have some definite information to give you. Unfortunately by the time your letter and one from Dr. Trimmer came telling me that the operation should be done here, Dr. Ward had gone on a vacation. I was unable to see him until two days ago.

Dr. Ward feel quite definitely that the operation should be done. It is very difficulty for me feeling as well as I do to see the necessity of it, but as you say in a situation like this there is nothing to do but take the doctor's advice. Dr. Ward promises to call me in the morning and tell me definitely what day he will operate, but it will likely be either the 24th or 26th.

I shall go <sup>to</sup> the Church Home and Infirmary, which is a hospital run by the Episcopal Church. Am hoping to get a room for about 4.25 per day. Dr. Ward seemed to think you would agree to that. There will be additional charges for use of operating room etc., but Dr. Ward will make no charge for his services. He thinks I shall be in the hospital about two weeks.

I donot know how you arrange for payment of hospital bills. I am so low financially that I can't advance it. Could you send me some money in advance, so the bills could be settled when due? Or could you write a letter to the hospital saying that the board was responsible? Do whatever seems best to you. Sorry I am so poor.

Dr. Ward thinks I shall be able to leave Baltimore about two months after the operation. I am certainly sick about the delay.

You will be interested to know that I am greatly improved from the sciatic treatments. I have a bill from them for \$12.00 for the treatments during July, but I think we will not settle that now. Have had about six treatments in August. There will only be a few more until I enter the hospital. Think the whole bill can be paid at one time.

One day next week I hope to go to Philadelphia to Arthur H. Thomas. Want to return to them a microscope they loan me for study while I have been home this year. Also to see them regarding some supplies and equipment that I want ordered for the laboratory in Nanking. However I am not placing an order until confirmation comes from Nanking.



Let us acknowledge receipt of your letter of November 2nd.

We enclose herewith a check for \$110 to your order representing travel allowance from New York to Nanking. We will be purchasing your steamer ticket within a week or two and will send it along to you when it arrives.

We have checked with the Chinese and Japanese Consulates and find that there is a charge of \$10 for the Chinese visa of an American going to China to teach and a charge of \$2.64 for the visa of an American citizen travelling in China. There is no charge made for Japanese visas. We will be glad to secure the visas for you and Miss Chin when your passports reach us.

We will be glad to pay your December salary before you sail. If satisfactory to you, we will send you, about November 25th, a check covering both the November and December salary.

Our accounting office has made a notation of your request that we resume the deduction of \$20 each month from your salary, sending this amount to your mother in Baltimore. You do not mention the month when you wish this deduction resumed, but unless we hear from you to the contrary, we will begin with the December salary.


Did you realize that my ticket reads from Vancouver to Hong Kong? I took it to book's Friday morning to see if there would be any difficulty about my

My dear Mrs. Bauers

We have your letter of August 21st and fully understand your anxiety as to the safety and welfare of your daughter just at present. All of us are deeply distressed and concerned over the tragic events taking place in China. We realize that the situation is a very serious one, and that conditions may quite probably grow worse before they begin to improve.

On the other hand, there are many encouraging evidences that for the most part the people of China and our American workers there are going steadily ahead with their regular duties, and have not been seriously interfered with because of the military disturbances. We have not had very much cabled information directly from Nanking, but that in itself is encouraging. President Chen cabled us last week that all was well on the University campus. President Wu of Ginling College also cabled that all was well and added, "No news is good news". We understand that both the University of Nanking and Ginling College are planning to open their regular autumn program in September, though Ginling has announced that its opening will be postponed two weeks because of the conditions in the lower Yangtze valley.

We enclose herewith a general letter going out to a number of our friends at this time summarizing the information which has come to us from each of the Colleges participating in our Associated Boards.

We will send to you from time to time any special information from Nanking which we are able to secure.


