I noted receipt of your letter of December 28th regarding \$1200 paid to the Methodist Board in my letter of this date regarding the United Hospital, but I have decided to add a sentence that should be remembered in connection with this \$1200 payment. *attached

It should be remembered that there was a bill of goods ordered at the instance of Dr. Cheer for E.E.N.T. goods amounting to twelve hundred and sixty odd dollars. He desired to retain personal possession of these goods. That was agreed to providing he would pay the University their purchase value. This he promised to do.

To replace these goods a \$1200 E.E.N.T. order of Dr. Peterson's Methodist Hospital was taken over by the University Medical College, payment for the same to be made to the Methodist Board of Foreign Missions.

This order ^{of} E.E.N.T. material was a part of the Rockefeller Foundation grant of \$20,000. This item has not been reported to the Rockefeller Foundation since it simply refers to an exchange of goods of approximately equal value. The difference in price between Methodist purchase and the original cost of the goods, amounting to sixty odd dollars should be, as a matter of course, placed to the credit of the Rockefeller grant on the University books for the purchase of University equipment ~~to that amount.~~

I thank you for your letter of December 21st with its kind words and for your Christmas greetings to Mrs. Beech and myself.

The cable message that you quote as follows: "Urge permission erect pharmacy building", was probably caused by a letter of mine to President Dsang calling his attention to the fact that permanent buildings erected on the campus should have the approval of the Board of Governors.

I was informed that materials were being collected for the erection of one of the two proposed pharmacy buildings. I was later informed that building funds were in hand for the erection of the first or smaller unit of these two pharmacy buildings. Two thousand dollars was contributed from Canada. Other gifts were not specifically reported, but they come from other donors including Chinese or the Chinese Government.

I surmise that this cablegram was sent to ask us to urge permission by the Board of Governors for the erection of this building at the January meeting of the Governors Executive. I am prepared to recommend erection whenever we can have a meeting authorized to deal with this question. *Plans drawn on the field by architect Young are reported enroute. I have one blue-print copy of the front elevation only.*

I have looked through all the minutes that are available here regarding the United Hospital in Chengtu. I am sure that the contract calling for the set-up of this United Hospital organization was sent to me before I returned to China about two years ago. It may have been stored away in the basement along with other material that I did not deem necessary to take to Chengtu. There should be a copy of that United Hospital agreement in your files. If there is not, action by the University authorities should be in some of the ^{minutes} minutes sent forward in 1938. If this cannot be found among your files, I suggest that you call Mr. Cartwright for the loan of his copy. I am certain that the matter came to the Mission Board's because action was required of them.

Quite aside from the contract, I am certain that the West China Union University is an actual, if not legal, participator in the United Hospital. All of our clinical work is done in the United Hospital and several of our University Medical-Dental staffs ~~are~~ represented in its teaching and administrative staffs. I am also certain that the University has allocated funds to meet a deficit of the United Hospital on at least one, if not two previous occasions.

I was informed that materials were being collected for the erection of one of the two proposed pharmacy buildings. Other gifts were not specifically reported, but they come from other donors including Chinese or the Chinese Government.

In reply to your first and second paragraphs: -
I judge that conversations of Mr. Cheng, regarding which I will observe "under cover", have tended to create unstable equilibrium. Suggestions of the other made would have been a timed better if made before Mr. Cheng left Chengtu, in which case he might not have left with support of H.Y.S.

I appreciate the forces at work through Japanese channels that emphasize Chinese Cultural (Ancient) studies for "New Order" reasons; and that this may have produced an opposite reaction among China's enlightened intelligentsia. I also appreciate the war psychology that calls for hands on the plow or fingers on the trigger, but that should not blind out cultural values that enrich a people & promise re-vival. You may recall the builder of the Great Wall burned the books of poetry, philosophy and higher learning, and had the bones of scholars buried in the wall sprang to life.

All this may be beside-the-mark, but it was in mind when the advice to return "with open mind", & weigh the realities as he views the landscape one.

We should not forget in this instance - that "well co-ordinated document" which came from the H.Y.S. Trustees to the Executive Comm. in Toronto, in advice

The field is requesting further action on the erection of the dental clinic. You will recall that you stated in your letter of October 11th to the field that there was \$1,200. available for this work.

Gentlemen:

According to our records Dr. Beech served forty years in China, eighteen years under the Board of Foreign Missions of the Methodist Episcopal Church and the balance under West China Union University.

The present basis for retirement under our Board for a man and his wife is \$18. a year for every year of service.

If Dr. Beech were granted the retirement allowance for forty years at \$18. a year for each year of service, his retirement allowance would be \$720. In view of the disability of one dependent, an allowance of \$260. is added, making a total of \$980. a year. The share of the Board of Foreign Missions for eighteen years of service on the above amount is \$441. a year.

As the pension allowance has been changed by the Board of Foreign Missions from time to time, it should be understood that the annual payments from the Board of Foreign Missions of the Methodist Episcopal Church may be subject to change.

I am transmitting this letter for your records in order that you may have a clear understanding of our responsibility.



A letter from Mr. H. D. Robertson, Chengtu, included in clipper mail to Mr. Evans + forward here by Mr. Evans says " Parker's letter... with yours, has been considered by Pres. Dsang Mrs. Lindsay (present Librarian) and me. We decided to cable "Approach Li". We take it you would approach Li + offer him the position on the conditions set out in Mr. Parker's letter. We agree he should have ~~position~~ ^{rank} of professor. You know the salary scale of June 1940, minutes. We... must leave the actual salary to you - as we definitely wish to have Mr. Li appointed Librarian...."

Why that cable to you did not read as Mr. Robertson's letter states, "Engage Li," I cannot guess, unless it is easier to say what one does not mean. Lack of definition is a common human trait.

Perhaps this may apply to Mr. Li. Will you therefore enquire if Mr. Li left for Shanghai, as he wrote he planned to do. If he has done so, I suggest that you send Clipper letters to him in Shanghai contracting him for position of WCUU Librarian, with rank of professor and salary of professor. (Salary scale is shifting due to costs of living rates) If I recall correctly, you were given Li's Shanghai address on my card.

Robertson states that the question of his family we will have to meet & that also applies to a house.

You may be aware of the fact that houses on the WCUU are like top seats in heaven - difficult to attain.

But since they are urging Li's appointment, do what you can by letter to secure him - and that at once. My reason for the cable was to read off a possible contract with the "Accounting Co" care of which he is addressed.



AGREEMENT made this day of November, 1940 between the BOARD OF GOVERNORS OF WEST CHINA UNION UNIVERSITY, party of the first part, and the BOARD OF FOREIGN MISSIONS OF THE METHODIST EPISCOPAL CHURCH, party of the second part, covering retirement for Dr. Joseph Beech.

It is the understanding of the said BOARD OF GOVERNORS, party of the first part, that Dr. Beech sailed from America on October 4, 1899 and arrived on the foreign field in January, 1900. At the time of his retirement forty years had been spent in service in China, eighteen of which was in the service of the BOARD OF FOREIGN MISSIONS, party of the second part. The present basis for retirement under the said party of the second part is eighteen dollars (\$18.00) per year for service which would produce a retirement for Dr. Beech of Seven Hundred Twenty Dollars (\$720.00). In view of disability of one dependent, Two Hundred Sixty Dollars (\$260.00) is added to this amount, making a total of Nine Hundred Eighty Dollars (\$980.00).

As Dr. Beech served 18/40 of the time with the BOARD OF FOREIGN MISSIONS, it is

AGREED that the said Board will furnish directly to Dr. Beech 18/40 of Nine Hundred Eighty Dollars (\$980.00) or Four Hundred Forty-One Dollars (\$441.00) per year.

It is further understood that the party of the first part desires to continue the salary of Dr. Beech at the same figure as the year last preceding his retirement. The basic figures are as follows:-

IT IS FURTHER AGREED that the said party of the first part continue

In the event that the basis of retirement of the party of the second part increases or decreases, it is understood that annual payments from both parties will be adjusted on the same ratio of years of service, as outlined hereinabove.

I have checked up in regard to Mr. Augustine Li, and Dr. Goodrich reports that he left here with just five days in which to reach the steamer, and that he expected to go directly to California and sail. I have also found out definitely that he left at the time expected, and that he hoped to see you in Chicago but apparently was unable to do so.

I have written to Mr. Li in Shanghai, enclosing your letter and asking him to reply to the offer directly to the people in Chengtu. I have also sent a Clipper letter to President Dsang and Mr. Robertson, telling them what we have done, giving Mr. Li's address in Shanghai, and suggesting that they will probably be hearing from him shortly.

I do not believe there will be anything else for us to do in this matter, unless the arrangement for Mr. Li fails in some way. In that case, we will have to make a search for some one else.

I passed on to Mr. Evans your note regarding the Pharmacy building, and I believe he is writing you concerning it. We are sending a request to the Executive Committee regarding the use of the funds for the Pharmacy building, and we hope to have a response from the members very shortly.

Thank you for your word regarding the "Statistical Review" which you used at the First Methodist Church in Evanston. That is one job on which I will always look back as one of the most interesting and enjoyable tasks it has been my privilege to do in my missionary career.



Dear Mr. Evans:

Since receiving yours of February 20th regarding the books collected by Dr. Campbell, together with copy of my letter of June 14th to Dr. Campbell and copy of Mr. Meekan's to Dr. Canright; I have talked over the matter of these books with Dr. Brown.

I asked him to convey to you the subject matter of our conversation. In brief it was: For Dr. Brown to take the shipment under his care as far as Rangoon or Bahmo, Burma. Bahmo is the steamship terminal on the Irrawaddy River, about sixty miles from the China border. The books to be left in care of the aviation corporation near there, until such time as transportation could be provided to Chengtu.

The other alternative is to take possession of the books and store them at the University expense preferably in Boston. I think Dr. Campbell would cooperate in this suggestion, - if, upon further consideration Dr. Brown does not feel like taking responsibility for them to the points mentioned.

As I understand it Dr. Campbell was asked to secure these medical journals by the Dean of the medical faculty. If I am correct in that, there ought not to be any question regarding expense involved in the care of and shipment of the books.

Dr. Brown is of the opinion that a steamer will leave shortly from Boston for Manila or beyond. Dr. Brown plans to leave on March 21st. I forgot to ask the name of the port from which he will leave. However he should be in New York by the time this letter arrives.

A previous letter from you concerned matters of a financial nature. Since I intended this \$1166.25 to be made available to Dr. Brown for the purchase of equipment at Shanghai, I suggest that you inquire if he would like to take this amount with him for the purchase of equipment in Shanghai or elsewhere. I acknowledge yours of February regarding Mr. T.K. Cheng and books that he expects to purchase. Of this I have written to you in a previous letter.

Unless circumstances unforeseen change intentions that are seen, I should be in New York about the middle of March. Continue to forward mail here until definite word regarding my departure from here is sent to you. Cordially yours,

Your letter of February 25th is at hand and we have written to the American Board regarding the books assembled by Dr. Campbell. After a conversation with Dr. Brown and also after a study of the storage facilities of the Methodist Board, we have decided that it is best to try and store the shipment in Boston for a period at least.

Dr. Brown left the office last night and has started westward. There are a lot of loose ends which have not been cleared, but trust in the course of events things will work out satisfactorily.

I note your paragraph regarding the \$1166.25 and have not discussed the matter with him as the matter was put through our books in the usual way, as indicated in my letter of February 18th. We certainly got you wrong on this check, but your letter of November 13th indicated that this was an adjustment which was to be cleared through our books and the paragraph referring to the setting up of an account to which this might be credited never occurred to us. We have discussed with Dr. Brown the possibility of giving authorization through the Associated Mission Treasurers, and before sailing he is to let us know what amount might be approximately the right figure for his use.

Up to the present time we have received less than \$3,000.00 from Dr. Brown as the result of his effort toward procuring additional equipment.

A cable came to hand from Chengtu this morning which reads as follows:-

"NO NEWS BROWN LABOUR COSTS RISING ALARMINGLY PLAN BEGIN REMAINING HOSPITAL SHELL WITHIN FORTNIGHT FAILING TELEGRAM."

We are getting in touch with Dr. Brown today if possible by telegram or telephone, as it was our impression that he had acknowledged

I find that your letters of January 30th and 31st have not been acknowledged -- probably they appeared complicated, but I am directing myself to them with fortitude and determination.

One letter deals with the special request from China for books from the Kate Atherton Fund. I shall be happy to remind the field that such purchases are in line with their own budget. We have proceeded with the purchase, however, of these particular items.

Our report on Fortune Magazine is that it is \$7.00, plus \$2.00 for foreign postage. Upon receipt of further instructions, we shall be glad to proceed with the order.

Your letter of January 31st deals with a number of items, some of which have been properly cleared. For instance, the cable regarding the Pharmacy has been sent -- action having been taken by the Executive Committee.

We have also received word regarding the request for scholarships, but will make a note of this as being a further demonstration of the need for action.

We still have no report on the equipment which was held up at the Chinese border when Mr. Albertson was taken ill.

I am sure the Finance Committee will not desire to take definite action on the request for US\$600.00 from Harvard-Yenching Institute Funds for books. Between the two of us, the handling of the budget this year has not been done very intelligently -- either that or they are maliciously endeavoring to change the appropriation to drafts in gold rather than the local currency appropriation. So far, not one dollar of local currency has been drawn.

We cancelled immediately Requisition No. 00283 on the order for Mrs. Lindsay.





I have written to Miss Norma S. Thompson, Secretary of the Rockefeller Foundation to make an initial advance to you of \$2500 as a credit against bills to come for the West China Union University Hospital.

I have also written Mr. Rollin C. Dean of the R.F. to place orders that will amount to approximately \$2000 and send the invoices to you for payment.

Again, he was told that if he desired duplicate copies of the lists of articles to be purchased, I was sure you would accommodate him if he would phone the request or send the sheets to you.

So much for the orders and payment of this quota.

I am reserving \$3000 for possible X-ray purchases, as and when the University cables instructions. \$5000 is reserved for hospital furnishings, lighting and water equipment. These may be purchased in Chengtu, or Hongkong or here as desired. On this last item I have written them that they were free to order the goods and send bills to you for payment. *122 76*

What I would like to have you do regarding accounts of this ~~account~~ grant from the R.F. is to open a special account on your books "WCUU Hospital, R.F. grant, of 1941". Bills may come in from several directions but I will aim to have the cash on credit before the bills reach you. Then please keep all invoices or bills paid for the rendering of our final account. The deadline for this grant is Dec. 30th, 1941.

I asked for, but did not get anything for freight charges. We may be able to save something, discounts etc on the purchases or order less than my schedules listed. I have asked Mr. Dean, as a favor to a friend, to look after the shipping, extra invoices for customs etc and bill you.

Here is a tip-off to you. "Priority" will probably have all freight space on steamers leaving N.Y. for the Orient after July, if not before. I am aiming to get my orders in before them.

We have just received from Mr. Fuller in the Associated Mission Treasurers, Shanghai, a bill for something over U.S. \$1000.00 for electric wire bought by Dr. Brown while passing through Shanghai, or rather ordered from England by him. Unless this can be paid for by funds in the U.S.A. I know of no other gold funds to meet this bill. I believe that at least one quarters payment of the China Foundation gift for equipment made two or three years ago was turned into gold. Is this included in the \$3233.63 you mentioned? If so, can this be used for the wiring? I think Miss Priest is expecting to get the money from that fund."

Dear Mr. Evans:

Prior to answering yours of June 9th, I have travelled through correspondence to and from Dr. Kilborn. To date I have not found any clue except the quotation written above from page (3) of his November 8th, 1940 letter, regarding your reported draft through the Associated Mission Treasurers for \$1068.15 marked "charge to Dr. Beech for hospital equipment".

I do not regard my statement to Dr. Brown that I had gifts for hospital equipment credited with you as authorization to draw payment for wire which Dr. Brown ordered without authorization from anybody so far as I know.

Dr. Brown informed me that he had ~~reached~~ made this purchase when he reached the United States, and I assumed that he would pay this bill from his ~~own~~ gifts received.

You do not state when you received notification of this draft through the Associated Mission Treasurers. If you have received it recently, perhaps it was sent forward to you from Mr. Fuller by authorization of Dr. Brown as charged against my gifts for equipment.

In my request for funds for equipment from the Rockefeller Foundation I included \$1500.00 for lighting equipment, ~~I expected that~~ wiring and fixtures. Dear Dr. Beech:

We have just had a telephone call from Mr. John Marshall, of the Rockefeller Foundation, inquiring about Mr. Mark Tseng and his relationship to the position of Librarian at West China Union University.

I am not familiar with what contacts you may have had with Mr. Tseng in this connection. Mr. Marshall says that Mr. Tseng is supposed to go back to China this summer and is having some difficulty about getting sailings. At the same time, there is the question of where he will expect to go in China and, if the University wishes to consider him for the position of Librarian, some definite understanding should be reached as soon as possible.

We have no record here of Mr. Tseng's background, but Mr. Marshall tells me that he was a fellow with the Rockefeller Foundation from 1936 to 1938, taking training in the library work at Columbia and the Library of Congress. Since 1938, he has been an assistant in the Harvard-Yenching Library.





The enclosed Air Mail from Dr Hsieh arrived this morning. Some thing should be done re meeting Hsieh's position. I suggest:

① that you take up his case with Dr Decker. Hsieh is on of the Baptist Corps in the University. ② that additional cash be given him or made available at Hong Kong.

③ that you recommend the trip to Manila, costs \$400 or less, ascertain the costs of steamship fare from Manila, or Clipper, to Hong Kong (if my memory is all right, the clipper fare is US\$90+)

④ that this advance sum be charged against the budget of WCUU, with confirmation by Executive later on, provided it cannot be taken care of otherwise.

⑤ As Dr Hsieh's contract with S. H. Hospital expires July 31st

Dr Hsieh would like to take 4 months in the G.E. X-ray plant here. I have seen their report mgr. who promised grant in aid of \$100 per month for 4 months. This will take care of him, but not enough for his wife also. If you care to take chances on no war in Far Eastern Pacific at end of 4 months, it would benefit University to help, as necessary, for Hsieh to take this X-ray work. See Welford's opinion in enclosed.

Thank you for your card of June 19 in response to my inquiries about the address of Dr. Lambert, and the matter of the Librarian at West China Union University in relation to Mr. Mark Tseng.

I am trying, through Mr. Marshall, to arrange to see Mr. Tseng and talk with him about the position at Chengtu. As soon as I have made further progress in the matter, I will let you know.

Mr. Evans is in constant touch with the steamship companies about accommodations on the Pacific. I have checked with him on the question of the "President Harrison" and he tells me that it is entirely booked, and that there is no possibility of getting anyone else on this steamer. He says that this was true even before the other ships were withdrawn. There is also some question as to whether the "President Harrison" will sail beyond our Pacific coast. The possibilities of freight lines are being explored and some passengers may be gotten as far as Manila in this way. Dr. and Mrs. Ho are on our list for arrangement for passages just as soon as accommodations can be gotten.



In accordance with your advice, we have secured the passage for Mr. and Mrs. Ho on the Dutch ship leaving California July 21. Including taxes, their tickets are costing \$835. This has been charged to the West China University account.

I am somewhat perplexed concerning the ultimate disposition of this amount. We recently received a cable from the four presidents on the Chengtu campus, indicating the serious financial situation brought on by the inflated prices in West China. Furthermore, a letter from the University tells us that the administration is stunned at the rising cost of travel. The budget has already been seriously overspent.

Could you help us to find the money necessary to send our friends back to China? Something will have to be done quickly to solve this problem.

What should we do as regards Dr. and Mrs. Shieh? Do you wish us to secure passage for them on this same steamer? If you do, please telegraph us immediately.

The entire steerage of the ship leaving on the 21st has been reserved for Chinese students. We hesitated to book Mr. and Mrs. Ho in steerage, but it probably would not be too late to secure passage for some of our other friends by steerage if you think it best to do so. The cost is only \$135. to Manila.

We are telegraphing the Hos that their tickets are being sent them by airmail.

This is a response to a letter from Mr. Robertson forwarded by your office. In this letter he refers to some matters that I covered as best I ^{could} in a letter to the President & HDR dated June 6 - July 6.

I wish you would advise me regarding their United China Relief askings and hopes for others to ask. Is it understood that China Relief Comm gets money, but allocates it all to the seven or more bodies for their respective distribution? If this is right what becomes of their request for \$50,000 for hospital equipment from WCUU? What becomes of the four Presidents request for funds for the "China Technical Institute" mentioned in this letter? Should this go via your office or direct to Mr. Garside & MR/ Luce as they evidently have done? I have no light whatever re these URC procedures and I prefer to do nothing regarding these matters until I have your, confidential or public word regarding the right procedures. If requests of this sort are to have priority in the Colleges' share of funds, with the individual colleges getting what is left, we should know it. Mr. Luce was in Chengtu he may have started this idea. Please let me know, confidentially or otherwise, how these special appeals for URC are coming along, and the light sought on the above ?-?-?-? .

I know that the request for the hospital equipment \$50,000 came too late for consideration or inclusion last Spring. Can anything be done about it now, if so what, and in what manner?

Mr. Robertson says "Dr. Brown is somewhat better but not yet fully recovered." This is my first and only word that he arrived there or was ill. Have you information?

I told Pres. Dsang & HDR that they should address you unless regarding WCUU matters, unless or until you authorized otherwise. I suggested that they ask you to send me copies of their letters typed in NY, instead of enclosed from Chengtu. (Over)



Dear Dr. Beech:

I am specifically answering your letter of July 16th without embellishments, as we have a very limited staff today.

Regarding the \$50,000 request for hospital equipment, the agency can make a direct appeal to UCR without the authorization of the participating group. In other words, West China must first approve the \$50,000 as has been done by the Finance Committee. The Associated Boards must next approve it and this in a tentative way has been done by including the amount in our asking for the second and third stages of the campaign. This does not mean that it will or will not be received, but probably not, for it would seem that \$4,000,000 in addition to the \$1,000,000 in hand must be secured if this request is to be given consideration.

There is, however, one qualification in this statement and that is that the American Bureau is endeavoring to set up a permanent organization, as the American Red Cross and the Lease-Lend legislation will practically take away their entire business. In the program they are recommending, we have added \$50,000 for hospital equipment, as the UCR Disbursing Committee has requested the American Bureau to submit a program covering the entire medical situation in China. There is some prospect of this being given favorable consideration by the Committee.

Neither had I heard about Dr. Brown's illness prior to Mr. Robertson's letter I knew that he had arrived from the newspaper dispatches covering the attack on his airplane. The first of the week I hope to get off a letter to the field dealing with travel for staff members. A telegram from Ho just this minute came, asking for release from first-class to steerage which I am doing.

More than a hundred cases of equipment are ready to leave Philadelphia as soon as shipping facilities are arranged for the trucks which are being purchased by and through the Friends Service Committee. Their ambulance drivers will take the equipment through to Chengtu from Rangoon.



Dear Dr. Beech:

I am answering your letter of July 19th by paragraphs as enumerated.

1. Dr. Co Tui telephoned our office that three items on Dr. Brown's list would be furnished. They were as follows: a Dodge Panel Truck, a station wagon, and a diathermy machine. It was understood that the motor trucks were in Rangoon and delivery would be made there. A telephone conversation confirms this. About three weeks ago they shipped the diathermy machine to Rangoon. In this connection it would seem that Claude Thomson will have to be informed about this and make the effort to pick up the shipment on the way in.

2. We have a bill from the Liebel-Flarsheim Company for a Bovis Electro Surgical Unit with accessories. There is also a short-wave generator. This has been sent to Arthur Thomas in Philadelphia to be consolidated with other shipments going to Rangoon and to be taken in by Claude Thomson and Dr. Dye.

Mrs. Whiteside (not Whitehead) is sending you stationary you requested.

So you were the one to start the ball rolling about the changes in bookings for the Ho's. I have had quite a session with the steamship company representative this morning, because I gave approval to this change by telegram on Saturday. It seems that they do not sell steerage to women and if the ticket is split it leaves a Chinese lady in a room with one berth vacant. We had this in mind when we made the first reservation, but when the request came by telegram on Saturday it appeared that some arrangement had been made. I have been compelled to withdraw my authorizations and allow the company to follow its regular course. Of course, if they do not sail the money is to be refunded.

My dear Dr. Beech:

Your letters of April 10th and 14th came to hand this morning on our arrival at Hongkong. As there is Clipper mail leaving this afternoon I will try and answer as much as available information will permit. I secured considerable information in Shanghai but found it would be difficult to ship any of the things we need from that port. The Japanese are prohibiting shipment of electrical supplies, machinery and in fact most things to any place that is not under their control. Also the freight rate from Shanghai to Rangoon is more than it is from New York to Rangoon, that is US\$32. per ton; rate from Hongkong to Rangoon is HK\$31 per ton, which is much better but still higher than before the war. I will get further prices here in Hongkong especially for indent orders to be shipped from New York to Rangoon. You mentioned that you did not know what orders I had placed. You will find in the New York office a telegram or letter giving this information. You will also find a rather detailed list and suggestions about the equipment needed. I think this letter was written to Mr. Caldwell and he was representing West China Union University. It may be however that business matters will be handled by some one else. I am not clear on this point. I have placed orders for the two Diathermy machines - one a surgical unit, the second a short wave treatment machine.

Purchases. I asked the office to purchase -

- 1 standard typewriter, elite type - Royal or Underwood
- 2 sewing machines
- 2 general E. infra red bulbs (G.E.) about \$1.75 each
- 1 book of formulas

I did not place orders for any other equipment. Electrical switches and sockets or hardware was not selected as I wanted to wait and see what was already in hand in Chengtu, before placing further orders. I had purchased electrical wire last year. They now tell me it would cost 80% more than that at the present time.

Red Cross. Regarding the request list of supplies presented to the Red Cross, I agree with you the first section including drugs, surgical supplies and cloth will most probably be granted by them. In fact Dr. John Earl Baker had approved our request and then had to cancel it along with other orders in a cable to Washington. This was because they could not get transportation for the supplies already sent into Burma. So you will have that lever of our request having been approved. If we can convince them that we will be able to transport the goods they will likely authorize the purchase and shipment. In fact the section #2 of hospital and surgical supplies are even more important than the drugs since many of these drugs have already been shipped into China and we could probably draw from these stocks. But if possible get the entire order. I am sending you herewith* a slightly revised list. You may not feel it is wise however to introduce any new changes in your request to the Red Cross. We can use all of these things or distribute any surplus to any needy hospital.

I would suggest that no further purchases of X-ray machines be made until I am able to get advice from Chengtu. A portable X-ray was given to me in New York and will go with your shipment. Mr. Wm. R. Johnson of the Red Cross has his office here in Hongkong. He tells me that the capacity of the road is woefully inadequate. Mili-

tary supplies and some medical things have first place. He thinks it will be rather difficult to get much heavy material over the road. We may have to confine our shipments to the lighter things. I will try and contact Dr. Baker as soon as possible. He is now Director of the Burma Road.

American Bureau. You write that I telegraphed that the American Bureau was granting \$10,000. I intended to indicate that our grand total including the American Bureau was \$10,000. I think you will find the word total in the telegram. Possibly it was not clear. Except for special items on which we have conclusive information and on which we get good prices, I am delaying purchases until we are a little nearer to the total amount required. It will also be best to save some of these funds for permanent equipment items, which we are not so likely to get from the American Red Cross or other organizations. You evidently have the same idea. I also approve of your suggestion of holding the shipment and forwarding them together unless you find that increasing scarcity of shipping space, freight rates or government export restrictions makes it advisable to send things we already have on hand.

Building. I note what you say about going ahead with the shell of the remaining building. If possible I am in sympathy with the idea if there is any chance of getting the additional funds to modernize it and make it useful. These buildings have no chimneys or outside stairs, which makes them unsuitable for use without modernization. While coming over on the boat and while in Shanghai I have given this question consideration. I learned from some of my engineering friends that it is possible to build the shell of the building and put in temporary floors and light partitions probably of "Biteo" which can be replaced later with reinforced concrete floors which will make the building largely fireproof. It seems that the day is past when we should build a four storey hospital building in a center like Chengtu and not plan to make it fireproof. The Szechuan University buildings are being built fire proof. It is much more important that a hospital should be. But if it seems possible to do this type of construction I shall be glad to cooperate with your desire in getting the building up. But even then unless we can get the list of essential supplies we cannot make a hospital with just buildings. It was a great disappointment that the funds were not available to purchase these supplies last fall and get them in over the road before the rainy season began. It is doubtful now whether much can be done during this season.

Consignment in Rangoon. I do not know what facilities Rev. F.E. Manton has for handling shipments. They tell me that our Methodist Mission does this work. Rev. H. J. Harwood is there. But if you have some connection and prefer to ship to Rev. Manton it will be all right. Be sure to inform us and send the necessary papers so we can take delivery or authorize delivery to be made. I think this covers most of the items in my new information. You evidently had not yet received my letter sent back from the steamer when you wrote me.

Dear Dr. Beech:

I am returning herewith letters from H. H. Hsieh and Wen-chun Ho.

I have taken considerable time to study through this situation and find that, undoubtedly, we should have been more alert regarding the H. H. Hsieh account. There is, however, a loophole through which we can share the responsibility with you in that I find a field letter quoting a telegram which seemed to place the entire responsibility upon you. However, this does not excuse us.

We have had considerable difficulty in getting an adjustment with the Steamship Company because of the representations made by Mr. Ho. He has demanded a complete refund plus commissions, and presumably this was a desire to help Dr. and Mrs. Hsieh in their predicament.

I have agreed to all of this and find that, between the two couples, they secured approximately \$1100. We have also released to them the commission which Mr. Ho has claimed. I have tried to reassure the San Francisco office of the steamship line, and also the New York office of the character and standing of Mr. and Mrs. Ho. Their attitudes and representations were not very creditable. However, the incident is past, although quite frankly the New York office will do some thorough investigation before they sell us any tickets. They will be sure also that they are according to the rules of the Company and that there will be no changes later on.

West China has saved some money in this deal, but has lost something else which we certainly cannot afford to lose at the present time. When I say this, I also repeat that our own part in the office here must have had no little effect upon the attitude of our friends.

Dear Chancellor Beech:

Your card of July 14th and letter of July 17th reached me duly yesterday. We have done just as you advised in your letter. I sent two telegrams to Mr. C. A. Evans, one inquiring the transportation between Hongkong and Chengtu, and the other requesting to change our first-class tickets to steerage in order to save money for delayed expenses in Manila and Hongkong. I received yours and Mr. Evans' reply at the same time yesterday. In his letter I learned that the New York office is not in a position to arrange any transportation between Hongkong and Chengtu, and Mr. Evans suggested that we had better wire the University as soon as we arrive in Hongkong. So this settles our problem at least temporarily.

We are sailing tomorrow and hope to reach Manila three weeks later. From there, we have to change steamers for Hongkong. We have seen Dr. and Mrs. H. H. Hsieh and also Mr. T. F. Pen. As far as I know, they are going to sail on the same steamer and none of them takes first class. We will write you again as soon as we reach Manila, Hongkong and Chengtu.

My dear Mr. Evans:

This is to acknowledge yours of July 17th, July 19th, July 21st, July 29th and July 31st (2). I have answered yours of the 17th, acknowledged yours of July 21st, but without comment. I have the following comments to make on these letters and other matters:

I thank you for the information in yours of July 19th regarding the \$50,000 for hospital equipment and other matters concerning the American Bureau. In this letter you speak of one hundred cases of equipment being ready to leave Philadelphia as soon as shipping facilities are arranged for, etc. What are these hundred cases? Are they for West China University in part or otherwise? Where is Mr. Claude Thompson that you mention in yours of the 21st?

I am in touch with Dr. Gordon Agnew, who plans to sail from California probably in late October. I am asking him to render assistance in connection with the shipment that will be made by Mr. Rollin C. Dean and I have asked him to pick up the truck and station wagon and diathermy that Dr. Co-Tui was to send out. I need information regarding these items and how we can get authority to take possession of them. I had expected that Dr. Brown would go to Lashio, but a recent letter from him intimates that he has hopes of someone else bringing up the goods. I wish you would telephone or have a telephone message sent to Dr. Co-Tui with request that he write to me information that I can pass on to Dr. Agnew in regard to this matter. I received the "stationary" sent forward by Mrs. Whiteside and also your list of sailings, etc.

I think I have written to you regarding the sailing of our two families, Ho and Hsieh, I wrote the University and entrusted them to make financial arrangements if further aid was needed, by them enroute to Chengtu. I am sorry that Mr. Ho made trouble for your New York office and the Steamship Company. But I am glad that they have succeeded in getting in the steerage rather than in first class.

Yours of July 31st concerning \$227.55 and \$50.00 from Wesleyan University I wish that you would hold all receipts from Wesleyan until I see you in New York. The University received from the Methodist Mission that \$966.00

that the Methodist Board now wished to collect from us since it was paid over to you also. We must hold all Wesleyan money to make this adjustment. I judge that the University applied the money for scholarships, hospital beds in accordance with agreements for that year. I now have photographs of ten students that were awarded these scholarships. If I am correct in this they have spent the money before they have received it. In fact, since the money was turned over to you.

I may not go east until I go to the Board of Governors meeting in Toronto. Present indications that I will go to Toronto via Battle Creek and Detroit. I have an engagement at Wesleyan University November 9th, and I may go direct to Middletown from Toronto. If I do this I will not get to New York much before the middle of November. If you know of any reason why I should reach New York at an earlier time, please let me know.





Dearly beloved Dr. Beech:

It warms my heart to see your scribble, and knowing how I love it my charming secretary sent me your card of the 21st. I can readily see how I caused confusion by mentioning "two trucks" in reference to two different purchases.

By memory the matter stands thus: The two trucks secured by Dr. Brown are Studebakers and are held on hand in Rangoon and will be delivered upon proper application. I believe this has been written to Dr. Brown.

The two trucks which will be used under the good auspices of Thomson & Dye were purchased and paid for to transport the merchandise being shipped by Arthur Thomas Company, over the Burma road. As you know the Friends Service Committee is sending out fifty ambulance drivers and mechanics and they purchased fifteen Chevrolet trucks with all the money they had altho they had ordered seventeen. They offered the other two to us with the understanding that the merchandise referred to above would be taken in by the ambulance drivers and we could later sell the trucks if we wanted to. Robert McClure is on the way out to supervise the Unit and he promised to carry out this contract, if war permits.

Not so long ago we received a letter from Mr Robertson urging that the orders be gotten through and if necessary to purchase a couple of trucks for the purpose. So, you will see, we have worked along the same line of thinking as the field. These two trucks were paid for out of the University of Nanking account and left to the field to make the adjustments.

I hope this sets you right on the truck question. If not ask me another and address it to the office as I expect to be back in the N.Y. Area the first of the week. With more love than ever, I am

Dear Dr. Beech:

In addition to my letter dated Saturday night, I am writing regarding yours of the 19th.

The balance we have available in Dr. Brown's equipment fund is \$4,390.51. This is net after having paid the Liebel-Flarsheim bill. It would seem that the \$700. to which Dr. Brown alludes was taken before the balance was turned over to us, as we have no charge of this character on our books.

May I say that there is but \$1.00 downstairs which has not been sent up to us, but is included in the above amount.

I shall write to Mr. Robertson in reply to the letter you sent me, and will send you a copy of the letter. I am of the opinion, however, that it would be very inadvisable to pursue the question regarding Mr. Meng's scholarship without having more complete evidence in hand than is available in our office. I would think it best for us to give you all of these facts before arriving at any decision as to our approach to the Harvard-Yenching Institute. You are aware, of course, of the difficulties at the present time in getting Chinese into the United States. It requires personal acquaintanceship with the applicant by some American, as well as two sponsors, all of which are filed upon blanks supplied for the specific person. It is no easy task and requires an endless amount of time.

Dear Dr. Beech:

I am grateful for your letter of August 31 written on a day of good deeds, and for the privilege of reading President Dsang's letter and that from Robert E. Brown.

I am greatly interested in the report on the bombings of Chengtu. Truly it is getting near at home under these circumstances. However, there is a distinct breaking of Japanese morale reflected in under-ground reports which we have been receiving through several channels. I wish I had time to give you a complete resume on conditions as we see them today. Suffice it to remark that there is practically universal opinion that if Japan does not fight within the next two or three weeks she must face an ignominious failure and tremendous face.

I have read President Dsang's letter and sympathize with him greatly in the personal needs which he is facing. I am doubtful as to the propriety of the Board of Governors taking any action upon this situation as it would establish a precedent difficult to overcome and might in the long run work decidedly to his disadvantage. We recognize the good will and the gratitude expressed for the efforts made in the United States for assistance. We feel very humble, however, and wish it could be more.

We are frantically working in an effort to get funds for China unfrozen. All of our China accounts are frozen and the United States Government is acting the part of an ignoramus in its attitude toward such simple matters as the transfer of funds from one bank to another here in the United States.

I wish you were nearer where I could run in and talk with you from time to time as I need the stimulus which your calm quiet attitude always engenders.







When I started this letter I planned to enclose one to Mr. Evans dealing with the cost of living situation but recent events make that unnecessary. Please read and forward.

9--12--41

Dear Mr. Evans;--

Today's news is that Guam and Wake Island are in J hands while Manila and Honolulu are being attacked so it does not seem that Clipper or any other kind of mail for that matter, will be getting through for some time. So before this meets your eyes lots of things will have happened and you will have had some anxious hours planning to meet whatever situation arises in China. Meanwhile we are making a first attempt to get the Central Bank to take our drafts and if they accept them we shall be greatly relieved we have to send them to Chungking as the branch here is not staffed to deal with foreign exchange. So we shall not know for several days what luck we shall have. Shanghai and Hongkong are cut off completely from China except for the radio stations, the one in Shanghai being controlled by interests inclined to the Axis. The Sewell family is supposed to be in Hongkong but Dr. Mullett is said to have left on Saturday. We have no word of the Simkins and we presume the ship Dr. Agnew was to sail on never left port.

Your letter of Oct. 1st reported a gift to Dr. Meuser from Percy C. Magnus of \$250.00. we have issued drafts for this amount to Dr. M.

After reading your letter to Miss Priest as to our drafts we are very glad we kept strictly to the regulations as fixed by the Ministry of Finance and so avoided any possibility of our drafts giving you any trouble in New York. Until the Pacific situation is cleared up and in our favour I presume there can be only a nominal rate of exchange between China and the U.S. For long enough we all have been talking about the probability of this war breaking out and still now that it is on us no one seems to have much of an idea as to what the course of events is likely to be. A cable has come to the Baptists saying funds were being sent through the Bank of China we still are hoping the Central Bank will accept our drafts. But we would like to have definite information as to what funds are available as we do not want to present drafts that cannot be honoured in New York.

It is reported that on Tuesday a plane will take letters for the U.S. via Australia so we are sending this with a prayer. This morning the Japanese radio said the Kowloon was occupied and Hongkong had been given 24 hours to surrender or be blown to bits. Christmas Greetings.

As conditions threatened to blow-up at that time I retained the amount and authorized Dr. Kilborn to pay Dr. Lindsay the amount from my Chengtu account. Since Lindsay was paid from funds that we may rightly consider as equipment, I am returning the \$100 to you for credit to equipment.

From this same fund and funds deposited at the coast that may rightly be designated equipment or travel I have paid personal items amounting to \$120. This I am returning and asking that you credit it back to the equipment fund in your care.

I closed with you on Nov. 20/40 the AMT balance Sh\$1166.25 on your \$500, by an AMT check for this amount in your favor. You converted it back to gold on your books.

I opened several accounts to facilitate payments enroute and at Chengtu, these I combined with other funds at Chengtu and Shanghai. I sent to Mr. Fuller a check for Sh\$2700 to be paid to Dr. Brown for hospital equipment. (It might have been \$2400 as an unknown debit had been charged but not then reported). This Chengtu balance and the balance paid Dr. Brown cleared off the accounts, except the Hongkong balance, reserved for forwarding posts. If you have an account with the Am. Exp. Co. Hongkong, let me know and I will ask them to pay it to your account as I make little use of it. So, money in Chengtu, I have none; money in Shanghai I have none, may find it in the red; money at Hongkong I have none except at your call, about a dozen HK dollars, Hope you managed to leave the office long enough to see a little of the sky this summer, if not you may be running for a fall as well as an Autumn.





Dr. Agnew was in the office today, and we are trying to segregate the various shipments of supplies going to China, and more particularly those for which he is to take responsibility. As you have written regarding these shipments, I am asking if you will confirm such understanding as we now have on the subject.

- 1st - A miscellaneous lot of orders being assembled by Arthur Thomas Company, to be cared for by Drs. Dye and Thomson in cooperation with the Friends Ambulance Unit, and for which we have purchased two trucks.
- 2nd - Gifts from the American Bureau for Medical Aid to China to Mrs. Brown, consisting of two autos and a diathermy machine, to be picked up at Rangoon by Dr. Agnew.
- 3rd - X-ray equipment, two refrigerators, an incubator, and sundry laboratory glassware and equipment, being assembled by the Rockefeller Foundation, to be claimed at Rangoon by Dr. Agnew and transported to China.
- 4th - Various supplies donated by the Red Cross, which are to be packed and shipped to Rangoon. (Who is supposed to take care of the transportation to Chengtu?)
- 5th - The supplies ordered by Dr. Brown through you are not definitely on record in our office. How are they to be handled? (This is aside from the second paragraph above.)

Please give us an answer to each one of these questions to the best of your ability, as Dr. Agnew is very anxious to get the situation straightened out as soon as possible.

My Dear Mr. Evans:

In reply to yours October 15th and the inquiries regarding University shipments of equipment.

First Inquiry: Refer to Dr. Claude Thomson, 99 Claremont Avenue, New York, Apt. 421. Telephone number the same as Union Theological Seminary, Monument 2-7100, Extension 421. As I understand it, Thomson and Dye are caring for this shipment to be made from New York and Philadelphia, and I believe no assistance is expected from Dr. Agnew although Dr. Thomson has offered to assist us and has given the following address for any shipments we may make - The Arthur H. Thomas Company, West Washington Square, Philadelphia, with covering letters to Mr. William H. Liggett who is handling Thompson's shipping.

Second Inquiry: You have stated this correctly. I requested Dr. Agnew to call on Dr. Co-Tui or Mr. Wang and get authorization to take delivery at Rangoon.

Third Inquiry: You have stated the case correctly for all goods being assembled by Mr. Dean of the Rockefeller Foundation. I have also requested Dr. Agnew to connect with Mr. Dean. He has done this to my knowledge by telephone and I hope he has followed it up by a personal visit. Copy of these invoices should be in your office if Mr. Dean has requested payment. I am still in doubt as to ~~an~~ receiving agent at Rangoon. I am awaiting Clipper reply from the Baptist Business Agent and Treasurer at Rangoon as requested that I should do by the Treasurer of the Baptist Board, 152 Madison Avenue.

Fourth Inquiry: You have stated the case correctly, with the exception of my present understanding that these goods will be shipped through to Chungking or to Chengtu by the Red Cross. I have stated to the Red Cross that Dr. Agnew will be glad to render assistance if goods arrive before his departure from Rangoon. Our equipment is a part of a general very large Red Cross shipment to China, priorities and other new inventions have to be complied with.

Fifth Inquiry: At the request of Dr. Brown I turned over his large and miscellaneous batch of orders to Mr. Charles F. Neergaard, 41 East 42nd. Street, New York. I sent these orders to him on September 17th, with request that he quote what could be secured with estimates. I have failed to hear from him to date. I wrote him again, air mail, October 16th and I requested Dr. Agnew to see him. Will you favor me by getting Mr. Neergaard on the phone and ascertaining if he received these Dr. Brown orders. Dr. Brown's list is difficult to interpret. For one thing, I have letters from Andersen Meyer, Hong Kong, which indicates that some of the goods in Dr. Brown's list "have been sold". As I understand it they have been "sold" to Dr. Brown.

The General Electric X-Ray Company feared their ability to get our X-Ray machine to New York in time for shipment from that port. They promised to ship via Pacific port to Rangoon with expectation that the shipment would travel on the same steamer as Dr. Agnew. I am awaiting Dr. Agnew's arrival in Chicago to give him all the available information regarding this or other shipments. I will write Mr. Dean to make their shipments without waiting for the X-Ray.

Replying to yours of October 15th re Dental Clinic Building. I have given Mr. Maddock the information regarding the reported cost of the building that has been erected on borrowed funds. I know of his renewed effort and hope it will succeed.

Dear Dr. Beech:

One or two matters call for another letter to you. I fear the effort you made in July was too much as I have had nothing since. I hope both you and Mrs. Beech are well and that you had a good summer. It is thought now that Miss Robertson should leave China on furlough, overdue as she cannot resume her work at the office. She plans to go to Toronto where she has a friend. I have written to Mr. Evans to secure the necessary permission from Washington for her to pass through the U. S. on her way to Canada; you might check up on that as we must wait till the Am. Consulate in Hongkong receives word that permission is granted.

Board Meeting. We got another report home from the President but have had no news by letter of the meeting scheduled for the 5th and 6th of November, I suppose everyone wonders what we are thinking of when we keep on cabling for funds to meet the rice subsidies; but what are we to do when the currency of the country buys less and less, in other words depreciates at the rate of exchange remains the same. There seems no third road to take either we get more gold and carry on the work or we close some of the work and carry on what we can; you know how difficult it is to do that. Rice is now fixed by the government at \$45.00 per teo which means we have to pay our teachers \$35.00 for every teo they need, an average I think of five teo per month per teacher for the whole staff. The central government ought to subsidize all schools to this extent but they refuse to see it that way, and if this is not simply a war condition but really a new standard of living, the future does not look so good for private institutions. I have asked Mr. Evans for a cable, you too in my Oct. 3rd letter, immediately after the meeting of the Board and would appreciate a Clipper from you before you leave New York.

Agnew Cable. Gift of Equipment. Long cables came from the N. Y. office asking us to guarantee freight up to \$2,000.00 on supplies that apparently Dr. Agnew had secured. The Medical men fear there is danger of duplication as he may not know what you are trying to get. So we replied he must consult with you and you have no doubt been in touch with Evans over this. The transportation situation should improve under McClure and the Friends Ambulance unit; they expect to have seventy trucks and station wagons, etc. under them. I understand the International Red Cross, so-called, has disappeared and the personnel becomes the International Relief unit associated with the Friends A. U. and their men, Evans bros., operating the Kweichow service station, Thompson, Nanking Chemistry, and Dye are to bring most of the university supplies this year; our news of the sailing of Agnew and Mullett is scanty.

Beech cheques. Under the new arrangement by which the Central Bank takes all our drafts Miss Priest has sold your three cheques; Hazen fund for \$50.00 each, N.C. \$2130.00; one personal \$5.00, N.C. \$106.00. Please advise as to use. Mr. Evans has sent us two gold drafts through the Bank of China and we are trying to get them to put our account in gold with the Central Bank in Chungking; otherwise we shall lose on the exchange and also the premium which we are allowed between Chungking and Shanghai. There have been wild rumours recently of the rate of exchange on the dark market in Sh'au, as low as 30 for 1 Am. dollar but we have no reliable information.

Harvard-Yenching Funds. For three weeks Dr. Stelle, the associate of William Hung at Yenching, has been in town looking into the work of the three institutions here. He is a young man, Harvard Ph. D. and very keen to see the work of the institute prosper. His comments to us and his report to the Board of Trustees will I feel sure have practical results. I wrote you about T. K. Cheng and his ideas about salary; from every other aspect his coming bucks us all up and promises a splendid future. But we have not got the relations between the Museum staff and the Research staff and the Department staff ironed out as yet; this is a problem for the President and Mr. Fang and I know they are worried about it as the solution means adjusting the ideas of the mentrained in the old methods and the younger, modern-trained men. But at the present time we certainly are not doing what the Institute expects

us to do either in teaching methods or contents of courses. It is of course in the Middle Schools that the youth of China are being let down but that does not relieve us of our responsibility not only to give the best possible teaching to such students as choose to study Chinese but also to set standards for others to follow. I w question whether anything can be done till we have a Head of the department who has been trained in modern methods and who is prepared to reorganize the whole works; it is unfortunate that Dr. Fung-fu has not executive ability as he is our only man and it is so difficult to bring in someone from outside. Evidently the Board of Governors is letting us have the whole grant this year and that is rair; you remember how our peoples talked about the other institutions getting the annual grant and their Boards having nothing to do with it. I am glad to be able to report that Dr. Stelle regards our three Research men as good a in their lines and I hope the bulletin they are putting out gets Dr. E.'s approval. It will take a little time for the joint publication to find a smooth-working organization and under present conditions publishing problems are very difficult. But in the Christian Colleges we now have some of the very best Chinese scholars and if the H-Y Trustees make it possible for them to do their work under the most favorable conditions possible in these times they are doing something very worthwhile. Do you remember promising Mr. Wen, Head of the Research Institute that you would try to get for him certain equipment for the study of Phonetic and anthropology. I wrote once about this and I know you were interested in the problem. Here is the list again;- Oscillograph, Tuning Fork, Kymograph, one small type, one a larger type, Laryngoscope, a Sound Recording Machine and a moving picture camera. Added are now, Zund-Burgnets Voice Indicator, and a Nasal Olives (?) and a Stroboscope. You will have to consult with some one about these, and please mention them when you write so I can report.

Hospital and Medical College. You will be interested to learn that the clinic for students is now carried on in the O. P. D. of the hospital under the Dep't of Medicine. Dr. Liljestrang wants to move his work out here ar once but Dr. Brown does not favor the idea Also they are making it possible for a certain number of T. B. students being cared for in rooms in the O. P. D. section, the money coming from some orgainzation in China. There has been a check-up on the condition of the students' health this autumn.

I hope you are spending some time in New York this year and helping Evans deal with his many problems; his reports on the results to be expected from the United China Relief appeal are not optimistic and we must have extra help from some source. The Presidents carry on and did not get any holiday this last summer; Dr. Dsang is not well since getting back from th Chungking and will take a week or two soon. I was interested to hear Dr. Stelle remark that he had not met four brighter people in China, Their method of cooperation could be improved but there seems to be something in the Oriental character that he does not like being tied to routine and regular attention to business. I hope the Boards will always provide for the finances being looked after by a foreign member of the staff; it helps the administration a great deal.

Sent letter to Dr. Agnew on Nov. 27 Please forward the enclosed to Mr. John Small % Dr. Arnup, Mission Rooms, 299 Queen st. W. Toronto. He may have obtained joined the Canadian Navy by this time. What is Washington doing really in the negotiations with the J. ambassador; at one time it looks like an attempt to come to an understanding and then overnight the J. press talks as if war is on the eve. The latest effort being made by the J. to read into the words of Hull some inner significance implying Am. wants to keep on good terms with J. and is willing to do anything to avoid a scrap, is disturbing to the Ch. observers after all that has happened. I am inclined to think the allies are stronger in the East than in any other part of the world. And it now lookd as if the great battle may be fought in the Caucasus of all places. Kindest regards,

At all events I repeated what had been written from the file by Mr. Kilbom, that large saving in cost of erection of Dental Unit had resulted from going ahead with the building that was started, as you remember, from the so called borrowed fund by the Dental Dept for erection of the building. Regarding which borrowing the Executive of Bd or the Governors spent some time considering. In the first instance the money was advanced from the credit balances from "Emergency funds"

Later when the expected from Mr. Maddock did not come through, I advised that they use funds from the Hospital building fund since building work on that project was held up by action or lack of action by the B. G.

Under date of April 1/41 Mr. Kilbom sent me a statement of Hospital building & equipment funds. In this fire losses etc appeared, and a charge

of CA 64,261.87 = Circ. Wth \$3,800. From this it appeared that the original so called borrowing from emergency balances, (see over) had been charged against the ^{hospital} building funds.

This led me to ask for a complete account for the Toronto Governors meeting. That has been promised. Though I thought my generosity in approving of having the tied up hospital ^{used} old fund for the dental unit had resulted in the "emergency fund" borrowings, being charged to the hospital acct, I said nothing except to ask for a complete statement of account.

As a matter of fact I was glad that the use of these funds - borrowed or advanced led to a saving of fully 100% or more owing to the rapid rise in building costs.

I outlined this to Mr. Maddock & he commended my judgment. My object was to hasten the securing of the expected fund from the A.D.A. Mr. Evans (H.E.) is now at work with Mr. Maddock and I am still hopeful that the amount needed - or promised - will come through.

Under the circumstances we need to be careful not to complicate this matter, awaiting a complete and full statement from Dr. Kilbom, as promised. His statement that the building dental unit, was about finished implied some further charge to the CA 64 261.87. I did not report this exact figure to Mr. Maddock, as I recall, the figure of \$3,500 + was used. So with this confidential family conversation, better await the promised report. Cordially

Dear Dr. Beech,-

I had hoped to write you long before this date in order to give you pictures of the new dental clinic unit but the too many duties involved in the moving into the new quarters have prevented an earlier letter and still prevents me from sending the pictures with the exception of one. This one you will recognize as having been taken from the south over the settling-pool. Actually the picture is taken from the top of the new Pharmacy unit. The picture gives you a good view of part of the southwest end of the college and hospital block. Canning Young has not yet provided me with small sketches of the ground floor and second floor plans of the building. Therefore you can expect another letter from me in the near future.

The new clinic rooms are so great an improvement from our old out-dated quarters that one is tempted to do a bit of boasting. We are very appreciative of your efforts and interest in raising the funds for the erection and completion of the building.

The Hospital Building Committee is getting very short of funds and would be very grateful if you can in the near future turn over to the Board of Governors a gift for the erection of the building.

I have another matter in which you can be of help to us. We have at present three young dental graduates who wish to enter the U.S.A. next summer in order to take up fellowships in advanced dental studies. I had secured paying fellowships for two of these men before last summer and they were all ready to sail in July and August. Unfortunately the U.S.A. suddenly and without warning demanded that all foreigners, students included, should have two Americans domiciled in the United States to act as sponsors for them when applying for an American visa. This, of course, was impossible to accomplish in a short time. Therefore the men were not able to go. Will you be willing to stand sponsor for these men and secure another to act with you. I will provide you with biographical data which will help you to evaluate their character, personality, ability and future possibilities. According to the form of affidavit which I have seen it would seem that the sponsor must state that he has known the applicant personally. Such a condition will keep most students from entering the United States. It will be very hard for them to find people living in the States who know them personally to whom they can appeal for assistance. Will you take up with Washington this point and discover whether it is an absolutely necessary requisite. It seems to me that the Government's objective would be met if one of the sponsors be an American citizen living in China knowing the man and the other sponsor living in America and able to follow him during his stay there.

Can you help in this matter of securing visas, and if you can will you let me hear from you as speedily as possible as it takes a long while to get all papers in order before purchasing passage. I have had the experience now several times to get men started in April to get their papers and still by July no papers have been received. Having to write to Washington from here will slow up the progress considerably.

Monday morning, December the 8th, and a date to be remembered in American history I imagine. At seven this morning we heard the Shanghai radio announcer say that Japan had declared war on England and the U. S. and the J. troops were taking over the settlement. Banks were to be kept closed, and the Am. Consulate had advised all Am's to stay at home unless business made it necessary for them to move about. That is as far as I got then and it is now three o'clock. Everyone is excited. From J. sources come the news that the Oklahoma was sunk in Pearl Harbour and two cruisers at Singapore; also that Hongkong is being bombed by big fleets of bombers. A J. landing has been made some place on the Malay coast. We shall have a more satisfying picture of what is happening when we get the evening B.B.C. broadcasts. We know that President R. has asked Congress for a declaration of war against J. and that the British will follow immediately. But how was it possible for the aircraft carriers to get so far across the Pacific; their objectives must be very important because their chances of getting back must be slight and they must be written off as lost by the board of strategy. Price is getting direct telephone messages from Ch'ng and bulletins are being posted; I thought you would like to have this story of our reactions, if this ever reaches you and if this war leaves us anything to think about.

Tuesday. The news is still bad. It seems that the Oklahoma and the West Virginia have been sunk and Pearl Harbor badly damaged. Also the Japanese claim Wake Island and Guam and landings on islands of the Philippines. Hongkong is blockaded and telegrams are not being accepted here. The Sewell family is supposed to be there. But we are thankful for the reaction in the U.S. indicating a realization of the meaning of the war; it has taken a long time but we hope we shall not have to use the phrase "too late." Caldwell has written Spooner asking for a letter to Mortimore Graves; please send it on to him.

Greetings to Mrs. Beech and yourself.



Dear Dr. Beech:

Your letter of November 27th came to hand promptly and Dr. Agnew has come and gone. He has had access to this letter and, as a matter of fact, has a copy of those portions in which he is particularly interested. He has conferred with the Steamship Company and has been assured that there is sufficient space to care for the extra shipment which he is carrying. I have admonished him that money which he is spending must be reported to the Rockefeller Foundation and that settlement must be made with the field treasurer on arriving in China and forwarded to our office.

Dr. Agnew has been in touch with the American Bureau for Medical Aid to China and has secured a considerable appropriation for transportation of the goods donated by the Medical and Surgical Relief Committee, Inc. (I believe the amount is \$4,000.00). One of the conditions is that he will share some of the goods with Dr. Lim.

The order for Eogen & Company has been placed and they have promised to ship it in time to reach the boat Dr. Agnew is taking, which is the PERIDA sailing from San Francisco on the 26th.

We are hoping that material from the Auth Electrical Supply Company will be in readiness to reach this same boat. Everything is being done to hurry them along. Priorities, however, play an important part in present-day business and it is a thing we cannot overcome.

You will be interested in learning that the letter sent out to "Timers" has brought in more than \$150,000.00. That, and the article in the READERS' DIGEST will total more than \$200,000.

It is encouraging to know that the Washington visit inspired new hope. Please do not hope too much as "Hope deferred maketh the heart sick."

I am returning herewith the letter from Mr. Robertson.

the return of Miss Robertson, and this information has been passed on to the field. The last Clipper mail took these minutes as it was impossible to get them ready before that.

I notice the criticism about our attitude regarding rice subsidies and only last week came another cable signed, "BELLYANG" stating that the Executive Directors had voted for an additional subsidy. This, of course, means US\$50,000.00 for the entire group at Chengtu and this is impossible. We have sent out \$5,000.00 and a special committee of the Associated Boards has been appointed to give further study to the situation.

I am glad to know of the visit of Dr. Stelle from Yenching and that he is pleased with the work that is being done. This will not hurt the University in any way. Dr. Stelle has enjoyed the confidence of the Harvard-Yenching Institute and his recommendations are of considerable weight.

May I omit comment upon the operation plans for the new hospital. We have ample here to keep ourselves busy and to keep out of mischief.

I am in agreement with your suggestion to approach Dr. Elisseeff for equipment for Mr. Wen. This will have to be carefully worded and I am putting it on my docket for consideration at the earliest possible moment.

Your suggestion about the church is good. I cannot see money for this project in sight for some time to come.

I don't know how much I have helped you, but it is the best I can offer for today.

Dear Dr. Beech:

Do I judge from the lack of replies that I receive that--I do not write again? I remember once Dr. Endicott referring to the 'letters from wives' he 'chucked in the waste paper basket, some without scanning.' But then this is coming in my official capacity. And if it contains a bit of news--that is Miriam's share!

I am the kind of a secretary not so easy to find on the mission field. You ask 'Why?' Because I am not sure that on my own I would send this request to you; I am doing as I am 'told.' Missionaries so dislike writing a letter or a minute with which they do not agree, such individualists are they. Isn't that so? You may prove that my hesitancy is not necessary; in that case the gain would be ours.

This year we have reorganized our Book-purchasing Committee, taking in the two new members, Dr. Cheng Teh Kuen and Professor Wen Tsai Iu, the latter a very enthusiastic head of the Chinese Research Institute.... or as we call it, the Chinese Cultural Research Institute. C.C.S.--for short. Their desire to get a good start leaps beyond the budget which we have at our disposal for certain types of publications. They have moderated very satisfactorily their book lists to fit their 'pocket-books.' But the need of certain periodicals from their beginning of publication is their present desire. We do not know whether or not these can be secured--when the war is over. But Dr. Cheng is of the opinion that they can. And as it was in the case of the Young Pao, that is a large expense. I am not sure that you were here when we faced a bill far beyond our western book budget. It fell to me to see that it was met--though I had not done the ordering. At last I persuaded the Chinese Department to assist us--much to their reluctance. And now the Chinese Research Institute uses it all the time! At present the Chinese book budget is entirely taken up with the opportunity of purchasing those very valuable books which because of war exigencies are being thrown on the market here. And there is the probability that what is here may represent a large part of such not taken away to Japan. We hear that there is a tremendous amount of that done in the east. That even publishing houses have been taken over entire and all their stock sent to Japan. Too, both the University of Nanking and Cheeloo are keen to secure all THEY can. Competition in purchasing is strong.

On a separate sheet I will make a list of the sets of periodicals for which we are asking, and which they feel are much needed. What is your advice regarding their purchase? So long have you been a Santa Claus--and our good angel, that the first gesture is always toward you! This time instigated by Mr. Fong and Dr. Cheng. I ask for advice--they asked for the funds necessary.....

There is no need for me to expatiate further. There is no doubt of the need--and of the lack.

And now what can I tell you that you have not heard. Indeed though I am writing this week, I shall not be able to send this month probably. But it will be in readiness. And miraculously this is a slack time--the first I have had this autumn. I made another attempt to leave the Library in June. I am really very weary--

and cannot quite get over the disappointment of spending this whole term in tread-mill work, when I wanted to spend it in learning something about China. I thought I had 'done my share' for a non-missionary lady! There have been, however, compensations. We have had lately two bouquets, one from the Central University who made a public pronouncement of our 'great cooperative spirit'- the greatest in the Library! And second from Dr. Stelle who has been here under the H.Y. Institute. So few do we get that we certainly appreciate them when they come without any enlarging of our 'head size.' Den is certainly a marvel of serious work and responsibility- no holidays, no clock. I have turned over to him most of the duties in order that I can hold on when he needs me to be here. I am not very peppy these times--and last spring almost kuaed. Spent two months at the mountain to try and overcome the weariness, didn't succeed very well. Miss Robertson was with me for the two months utterly exhausted; her work was entirely too strenuous for one person and her Chinese assistant had been taken away. So now they have only a Chinese assistant, capable but not stenographic. She is still on her back, was expecting to furlough in April, but who will?

This autumn with the increased registration we have been busier than ever, the main and the four branches...we the bottle neck. You remember the suggestion you made to fill in that east section of the readingroom for offices? Then the Chinese Research Institute filled in the other side, but later got accommodation in the Friends College and so we now have the Chinese cataloguers in the north end. That leaves the stockroom free for teachers and very much more quiet. And we have space to work--and certainly look much more businesslike.

Our stackroom is full--and people's attics are full. And we can never bring back our books until the Museum moves or we have a new stackroom. And my study has a big bookcase in it--and Mr. Robertson's bedroom has a heap of political history books therein. He offered to take them in last bombing-season--and there's no place now to put them if they did come back.

From August, periodicals and book orders seemed to be coming with considerable regularity and catching up from January 1940. I think I wrote you earlier that the English books and periodicals were coming with much greater frequency than the American publications. The other day I was asking Dr. Rowe of the Library of Congress and he states that under present conditions the American has become disorganised, the English having more experience in transporting under difficulties, have been able to regulate more quickly the changes necessary to the changing of routes--under duress, I add!

I have just sent to the postoffice as to how much can go into a letter under the new route by Durban and so I think that I shall have to put the list on this sheet and skimp my extraneous remarks.



Dear Dr. Beech:

It was good to hear your voice again this morning, and it seems in order for me to report with the latest findings regarding shipments. First, the United Church of Canada has told Dr. Agnew they approve reshipping their trucks and equipment to Newport News, Va. Secondly, the China Defense Supply Organization has promised space for shipment of these goods from Newport News. They have also promised to provide passage for Dr. Agnew. Thirdly, the Medical Supply Committee providing the material for part of the shipment is agreeable to this transfer.

Dr. Agnew is inclined to make haste in starting shipment eastward to make this next boat if possible. It will go by the way of Cape Horn and Rangoon.

Mr. Dean of the Rockefeller Foundation is still investigating the whole situation, but in general agrees with the foregoing. The government states definitely that there is little chance of shipping from the West Coast of the United States.

This is hastily dictated, but carries with it an added measure of Christmas greetings.


